OCPP Cloud Connector Update

At the previous TAC meeting, Ms. Wolkoff spoke to the TAC about changes to her organization and as a result, she currently does not have the bandwidth to continue with the project. Ms. Wolkoff had a meeting with Mr. Möller, Mr. Mertic, Ms. Kilborn, and Mr. Huether, where it was discussed that EVERest would take on the repositories and the project. As such, a resolution to move OCPP Cloud Connector was made by Ms. Kilborn.

Mr. van de Bogaard motioned to approve the resolution to move OCPP Cloud Connector to an Emeritus Status. It was seconded by Mr. Jeanson and approved unanimously.

SOGNO Annual Review

Dr. Monti presented the SOGNO annual review. He mentioned there were some changes to the people involved. He noted key achievements and the growth plan. Dr. Monti would like help with collaboration with other LF Projects. A resolution was made to renew SOGNO for another year at the Early Adoption level.
